Public Utilities Report: Dave has questions on towing a vehicle parked on street that does not run and owner has been notified to move the vehicle. Discussion of how policy is written and how to proceed for the future. Dave reports work done at the water plant to increase the need to backwash. The process has resulted in only needing to backwash about once a week versus every day. Dave would like to have on record that he will not need to plow the new Kuester Pit 2 Second Addition roads until public improvements are completed. The roads are all gravel at this point and will stay that way until spring. Council is in agreement that no plowing should be done until the improvements are completed and turned over to the city.

Planning Commission minutes are included in the packet. Commissioners have been working on updating Comprehensive Plan in regards to zoning of new area around new highway construction. Dave Ubel took commissioners on a driving tour on the new construction to get views from that prospective and each commissioner will give their views on what each area should be. Councilmember Kraus asks if planning commission would also discuss the plans for removal of Co Rd 12 and the future of the area including utilities.

Clerk Report: Kuester Pit 2 Second Addition and starting to issue permits. The public improvements are for the most part completed except curb and gutter and bituminous which it is now too late in the year to do. Elevations are set along with property pins being installed. Clerk has been approached to issue permits now for party that has purchased nine lots and is ready to build. Council reviews agreement and pictures obtained and reports from city engineer. Council agrees to issuing permits and have conversation to resume street improvements including Collin Drive in spring as weather permits.

Clerk has agreement with Prokore for inspections after has been to the lawyer.

Clerk will have some days this coming month she will be off as per an email she forwarded to council explaining. The office will be closed December 9<sup>th</sup> thru the 16<sup>th</sup>. The office will also be closed December 26<sup>th</sup> for Christmas and January 2<sup>nd</sup> for New Year holiday.

Dirt Merchant final pay request pond outfall improvements. This is for retainage on the project in 2020. Clerk received an email asking if had been paid and after consulting with Bolton and Menk found it was missed. Bolton and Menk prepared the request for approval.

Rodewald made a motion to approve Dirt Merchant Final Pay Request 2020 Pond Outfall Improvements for \$1,166.81. Peton seconded the motion. Motion carried with all in favor.

Clerk has received inquiry to selling THC products. With no ordinance in place, businesses can sell without license or permits with the new law that went into effect July 1, 2022. Council will have planning commission look into what options are.

Steve Kloeckl is present for a Conditional Use Permit forwarded by Planning Commission after a public hearing at the last meeting. Council reviews notes and concerns forwarded. The improvements of the units has reduced the amount of debris or pollution older units produced to nearly nothing.

Kraus made a motion to approve Resolution 22-117 Approval of Conditional Use Permit for Outdoor Furnace Operation at 417 Riverview Drive, Courtland, MN by Steve Kloeckl. Peton seconded the motion. Motion carried with all in favor.

Clerk presents a resolution for transfer of funds. This is to close out loan from water/sewer fund used to pay off bond in 2018. The amount owed is now \$45,379.17. The assessments have also all been collected and those funds will be drawn from to complete the total along with the budgeted \$30,000.

2023 Budget: Council reviews budget for any reductions needed. Finding none, council agrees to keep preliminary budget as final budget. Currently budget is a 5.2% increase.

- 1. This CUP becomes void if not recorded at their expense by Steve Kloeckl at the Nicollet County Recorder's Office within 60 days of its approval. By recording this permit, Steve Kloeckl, indicate their agreement to abide by the conditions herein.
- 2. The CUP is valid for duration of operation upon approval and recording at the Nicollet County Recorder's Office.
- 3. The City may enter onto the premises at reasonable times and in a reasonable manner to ensure the permit holder is in compliance with the conditions and all other statutes, rules and ordinances.
