Public Utilities: Dave Ubel explained that the televising of the sewer lines is near completion. There are several issues identified in various parts of the city that will need to be addressed soon. The council recommended to City Clerk Julie Holm that she prepare a letter to all residents and businesses explaining that many cracks, leaks, broken pipes, grease and dirt buildups, and other infiltration problems were found in the sewer lines. The residents and businesses, who have problems on their property, will receive a second letter explaining the problems that were identified so that they can correct the problems. Ubel has already been working with one homeowner because of a rather large leak. Homeowners are responsible for problems up to their connection to the main sewer line. Mayor Poehler voices concern that homeowners know right away that they will be responsible for repairs as outlined in ordinance. Dave has engaged M & R to raise manholes that are low and in one case paved over.

Dave had meeting with city engineer Joe Duncan regarding Stony Point
Dave also discusses there was a gas line run through a manhole on Highview Court and this will be fixed during
the next week, homeowners will receive a letter from Untied Natural Gas regarding pending gas shut off during
the repair.

Mayor/Council Reports: NONE

City Clerk: Clerk will be taking October 6th off and office will be closed.

Rich Reichel, a developer in the Kuester Pit 2 Addition, was present to ask questions about what he can and cannot do as he develops the 17 lots that he owns. An example is to use on as a parking lot. Councilmember Bode commented probably need to combine two lots for one to be used as parking.

Reichel asked about what can be done with a vacant lot. Mayor Poehler indicates the development of the area into warehouses/storage sheds limits lots to no outside storage. A conditional use permit could permit parking.

Rich also had questions on recourse with Jason Kuester for completing development of the area. The development agreement stated the public improvements were to be done by Jason Kuester and should have been completed by July 1, the mayor/council recommended that he be sent a letter from the city's attorney giving him a short timeline to complete the project. The agreement focuses on the public improvements such as infrastructure including sewer and water installation, roads and stormwater drainage i.e. drainage pond development.

Fire Chief Dave Ubel recommended Danielle Schlumpberger and Tom Suess to the Courtland City Council as new Courtland Fire Department firefighters. The addition of these two candidates brings total to 23 firefighters which is the maximum allowed in the bylaws. Additional discussion brought up in regard to how hiring happens and if the most qualified candidates were hired. All three candidates were very qualified, two are married couple and discussion of certain factors taken into account when chosen as member.

Kraus made a motion to approve Danielle Schlumpberger and Tom Suess as new firefighters. Rodewald seconded the motion. Motion carried with all in favor.

Clerk Holm presented items for personnel policy updates needed; add Juneteenth as a paid holiday and Paid Time Off (PTO) with regard to new state requirement of earned safe and sick time. The law for ESST takes effect Jan 1, 2024 and updates to policy should take place before year end.

Clerk Holm presents Ordinance 23-104 Amending Part 3, Chapter IV Relative to Parking Regulation forwarded by Planning Commission. The amendments incorporate towing for violations of the ordinance regarding parking restrictions during season as well as during a declared snow emergency.

Rodewald made a motion to approve Ordinance 23-104 Amending Part 3, Chapter IV Parking Regulations. Bode seconded the motion. Motion carried with all in favor.

Bode made a motion to adjourn. Kraus seconded the motion. Motion carried with all in favor.

AUTHORIZING PRELIMINARY REPORT FOR THE PROPOSED 2024 STREET IMPROVEMENT PROJECT

WHEREAS, The City Council has identified a need to improve Collin Drive within the City; AND

WHEREAS, The construction of Collin Drive from 4th Street (CSAH 24) to the east shall consist of a bituminous street section, concrete curb and gutter, storm sewer, and other related municipal utility adjustments; AND

WHEREAS, The work shall hereby be identified as the 2024 Street Improvement Project and assessed to the benefited properties for all or a portion of the cost of the improvement, pursuant to Minnesota Statues Chapter 429; AND

WHEREAS, The City Council wishes to study whether or not the proposed projects are necessary, cost effective, and feasible.

NOW THEREFORE BE IT ADOPTED BY THE CITY COUNCIL OF THE CITY OF COURTLAND, MINNESOTA THAT: It hereby orders the preparation of a feasibility report by consulting City Engineer Bolton and Menk for the improvements to be known as the 2024 Street Improvement Project to include whether it should best be made as proposed or in connection with another improvement, the estimated cost of the improvement as recommended, and a description of the methodology used to calculate individual assessments for affected parcels.
