Public Utilities Report: Dave reports concerns with Xcel Energy placing power lines in right of way instead of utility easement meant for the purpose in the new development of Kuester Pit 2 Second Addition. The contact person with Xcel has changed and he was unaware, Dave is working with him for future plans. Dave also noted there were no street lights planned in the new development. Discussion whether city will be responsible in future to have installed. Additional comments that property owners could petition in the future to have installed.

Dave also had discussion with Xcel Energy representative that power lines to street lights up to new highway will be installed overhead, previous discussion was to put underground. Council would like Dave to make known the City would like these line to be underground installation.

Planning Commission: Held public hearing for Ordinance 23-103, no visitors attended. Commission forwarded

Ordinance to council for approval.

City Clerk: Clerk Holm had meeting with Mike Schwartz from Frandsen Bank regarding moving monies to their bank. They do offer an interest bearing checking which Alliance Bank does not. The city moved a majority of its monies to 4M Fund in October 2022 and put monies into CD's earning good interest rates. This option would be to have monies local and still earning interest. Additional notes on CD's with 4M Fund, there will be a CD coming due in July of \$200,000. Clerk will also need funds to pay PFA bond payment in August and will research needs before renewing CD, first half property tax monies have been received and LGA should also be arriving soon.

Clerk presents Ordinance 23-104 An Ordinance Amending Part 3 of Chapter III in regards to Land Preservation forwarded from Planning Commission after public hearing was held. Council discussion of language when state stormwater construction permits are in place.

Rodewald made a motion to approve Ordinance 23-103 Amending Part 3 of Chapter III with amended language of "In the absence of a state storm water construction permit, and", waiving the reading. Kraus seconded the motion. Motion carried with all in favor.

A RESOLUTION APPROVING PUBLICATION OF ORDINANCE 23-103 BY TITLE AND SUMMARY

WHEREAS, on July 6, 2023, the City Council of the City of Courtland adopted Ordinance 23-103 which amends Part 3, "Zoning Regulations: of the Courtland Code of Ordinances Chapter III; and

WHEREAS, Minnesota Statutes §412.191, subd.4 allows publication by title and summary in the case of lengthy ordinances upon a vote of 4/5 of the city council; and

WHEREAS, the City Council believes that the following summary would clearly inform the public of the intent and effect of the ordinance.

NOW THEREFORE. IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF COURTLAND:

- 1. The City Council of the City of Courtland has adopted Ordinance 23-103, which amends Part 3 "Zoning Regulations of the Courtland Code of Ordinances Chapter III. The ordinance is relating to zoning regulations on land alterations and land preservation in the City of Courtland with the purpose to promote the public health, safety, and general welfare by minimizing these losses and disruptions.
- 2. The City Clerk is directed to publish this resolution in lieu of publication of the entire ordinance.
- 3. The City Clerk is directed to post a copy of the entire text of Ordinance 23-103 on the City website for a period of not less than thirty (30) days. In addition, a copy of Ordinance 23-103 is available upon request, or for inspection by any person during regular office hours at Courtland City Hall.

RESOLUTION ESTABLISHING CITY REGULATIONS RELATED TO COUNTING OF WRITE-IN VOTES

WHEREAS, current voting regulations require election workers to count and tabulate each writein vote under certain conditions; and

WHEREAS, counting of write-in votes is time consuming on election night and rarely, if ever, results in a winning candidate; and

WHEREAS, recent legislative changes have provided cities with options for how to deal with writein votes; and

WHEREAS, the new State regulations provide the ability for cities to adopt a resolution requiring that either write-in candidates must submit a request in order to have their individual votes tallied, or write-in candidates will only have their individual votes tallied if the number of write-in votes for the contest is greater than or equal to the fewest number of votes cast for a non-writ- in candidate; and

WHEREAS, the second option is recommended for adoption in Courtland.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COURTLAND, NICOLLET COUNTY, MINNESOTA, THAT: the City of Courtland's procedure for counting of write-in votes cast during a primary, special, or general election, unless otherwise required by State Statute, shall be as follows effective September 1, 2023:

Write-in candidates will only have their individual votes tallied if the number of write-in votes for the contest is greater than or equal to the fewest number of votes cast for a non-write-in candidate.
